The main roles/responsibilities and Terms of Reference of the Project Management Unit will be as follows:-

- 1. All the members will be collectively responsible for the proper functioning/implementation/execution of the iTEAMS project.
- 2. All the members shall function under the control of the Chairman and shall execute such powers and perform such duties as may be delegated by the Chairman from time to time.
- 3. The Member Secretary shall be responsible to convene meetings of the PMU on a monthly basis by circulating the agenda in advance and also maintain all the records of the meetings including minutes.
- 4. The PMU shall be responsible for sanction of all the expenditures under the project and it shall submit statement of Receipt & Expenditure to the Directorate of Agriculture and Department of Agriculture & Farmers Welfare.
- 5. Any consultant/employee (contractual or permanent), retired Government Official can be appointed only after approval from the Chairman of the PMU and on written agreement.
- 6. The PMU on a need to basis may form or appoint Committees with members from within the PMU and also outside.
- 7. The Bank Account of the PMU will be operated by the Director of iTEAMS, Shillong.
- 8. Further, if the need arises the PMU can be shifted from one entity where it is presently hosted to another entity.
