The functions of the Tender Committee/Purchase Board :

1. To approve/screen NIT/NIQ/EoI/RFP/RFQ for settlement of works or purchase of goods and services to be made during any financial years before issue/floating of tender.
2. To consider/approve the Comparative Statement with recommendation on both technical bids and financial bids placed by the Tendering Authority.

The functions of the Tendering Authority :

1. The Directorate concerned will be the Tendering Authority.
2. To submit NIT/NIQ/EoI/RFP/RFQ document before the Departmental Tender Committee/Purchase Board before issue /floating of tenders.
3. To invite for Technical Bid and Financial/Price Bid through local dailies/regional/national papers/e-tender as may be appropriate.
4. To open **Technical Bids** and prepare the Comparative Statement along with recommendation for placing before the Departmental Tender Committee/ Purchase Board.
5. To intimate shortlisted tenderers who are found to be qualified by the Departmental Purchase Board/Tender Committee of the date, time and venue for opening of their **financial/price bids**. On such day, time and venue, the financial/price bids of only the eligible tenderers who are shortlisted by the Departmental Tender Committee/Purchase Board shall be opened by the **Tendering Authority** in the presence of such parties, as may desire to be present.
6. To submit the authenticated Comparative Statement of the financial/price bids along with recommendations for placing before the Departmental Tender Committee/Purchase Board for consideration and decision.
7. To return price/financial bids of all other tenderers who have not been shortlisted by the Departmental Purchase Board/Tender Committee, **unopened**, to such parties.
