### **ADVERTISEMENT FOR THE TECHNICAL POSTS IN KVKs OF MEGHALAYA UNDER DEPARTMENT OF AGRICULTURE AS HOST ORGANIZATION**

Applications in Standard Form are invited from Indian Citizens (as defined in Article 5 of the Constitution of India) of the State of Meghalaya for recruitment to the following technical posts in the Krishi Vigyan Kendras under the Department of Agriculture as the Host Organization on contract basis. Attested copies of all relevant documents and testimonials should be attached with the Application. Application forms without these documents shall be summarily rejected.

The applicants will have to appear for a Written Test and candidates who qualify in the Written Test will need to appear in a Personal Interview before the Selection Committee, duly constituted for the purpose by the State Government. Candidates canvassing directly or indirectly shall be disqualified.

- (iv) Applicants already in Govt. Service should apply through proper channel.
- (v) Preference will be given to those unemployed B.Sc/M.Sc Candidates sponsored as stipendiary or availed scholarship by the Department of Agriculture, Govt. of Meghalaya.
- (vi) Applicants who have a working knowledge of Khasi/Jaintia/Garo language will be preferred.
