Online applications are invited from applicants who are Permanent Resident of the State of Meghalaya for recruitment to the following technical posts in the Krishi Vigyan Kendras under the Department of Agriculture as the Host Organization on contract basis. Attested copies of all relevant documents and testimonials should be attached with the Application. Application forms without these documents shall be summarily rejected.

The applicants will have to appear for a Written Test and Candidates who qualify in the Written Test will need to appear in a Personal Interview before the Selection Committee, duly constituted for the purpose by the State Government. Candidates canvassing directly or indirectly shall be disqualified.


6. Age Limit :- 18 years to 32 years relaxable by 5(five) years in respect of Candidates belonging to Scheduled Tribes as per State Government's reservation policy.

7. Conditions of appointment: -

- (vii) The posts are co-terminus with the project and will cease as and when Govt. of India terminates the project.
- (viii) The scale of pay as adopted by the ICAR for all KVKs in the country shall be considered for the posts mentioned.
- (ix) The terms and conditions for service under the KVKs will be governed by ICAR norms as per "**Memorandum of Understanding**" agreed upon by ICAR, New Delhi and the State Department of Agriculture.
