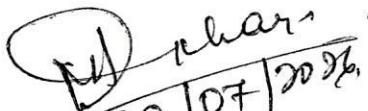

Description of the TREYSEFA Training Programme

1. The training programme includes classroom lectures, practical classes & exposure/field visits within the state.
2. The training programme covers subjects like Agriculture, Horticulture, Animal Husbandry, Fishery, Sericulture, Project Management, Financing, HRD and other allied sectors.
3. The training programme aims to open up opportunities for the educated youths to take up agriculture and allied sectors as an enterprise and a business.
4. The duration of the training programme is 2 (two) months for each batch.
5. The total number of trainees to be selected for each batch is 20 (twenty).
6. The selected applicants will be intimated for attending the training at the Office of the Principal, Basic Agricultural Training Centre, Upper Shillong as per the final decision of the Screening Committee and subjected to the performance of the applicants on the Personal Interview.
7. The training program is purely residential wherein free accommodation in dormitory along with fooding will be provided free of cost.
8. Stipend for the TREYSEFA trainees will be disbursed by the Training Centre through online mode (DBT/NEFT/etc).
9. Seed money will be disbursed to the TREYSEFA trainees through online mode (DBT/NEFT/etc) on their completion of the training to enable him/her to start their activity in two (2) installments.

Eligibility Criteria:-

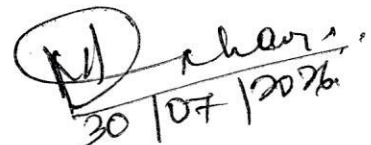
1. The applicant should be minimum SSLC passed & between the age group of **25 (twenty five) to 40 (Forty) years**.
2. The selected youth should have his/her own or parents' land that will be made available to him/her for implementation of his/her opted project/ activity after completion of the training programme.

Terms & Conditions of the Training Programme.

1. All the trainees will have to stay in the hostel of the Training Centre during the entire training period.
2. Minimum of 90% attendance is compulsory for the training programme.
3. All the trainees will have to abide by all the rules and regulations of the Training Centre.
4. Seed Money will be disbursed to the passed out trainees in 2(two) installments, based on the business plan and progress of work/activity opted along with the recommendation of the concerned Mentor.
5. If for any reason, seed money is not properly utilized for the purpose for which it is sanctioned or the project/activity remain incomplete or discontinued mid way, the concerned passed out Trainee will have to refund all the amount that he/she has received.
6. Timely evaluation as arranged by the Office of the Principal, Basic Agricultural Training Centre, Upper Shillong will be conducted for the purpose of monitoring the performance and progress of the passed out trainee.
7. If for any reason, a trainee leaves or discontinues the training programme he/she shall not be eligible to receive the seed money and the authority reserves the right to select the next candidate from the waiting list.
