#### STATE RICE MISSION SCHEME

**1. Kaei ka thong jong kane ka skhim?**

Ka jingkyrshan ia ki nongrep lyngba ka jingsam da ki dawai 'bio-pesticides' bad ki 'bio-agents' ki bym don jingktah ia ka mariang na ka bynta ka jingbha jong ki jingthung bad lyngba ka jingsam ia ki tiar rep kum ki sprayer bad ki tiar ai jingāda ia ki jingthung na ki khñiang/jingpang bad ban pynshlur ia ki nongrep ban rep tynrai khlem dawai (organic crop production).
